BOOKING TERMS AND CONDITIONS

By registering, guests agree to be bound by our booking terms and conditions and the guest house rules as listed below:

1. Registration/booking

Guests must coordinate their stay with our reservation service and then confirm their booking in writing (giving their credit card number, date of expiry and check digit). The contract becomes effective on acceptance of the registration by Food & More GmbH. Enquiries regarding short-term stays (up to 2 nights) will be confirmed four weeks prior to arrival at the earliest. Bookings will be accepted for next year following publication of the opening times and prices.

2. Guests' liability

Guests shall be liable for any damage or loss caused by themselves, their family members and/or friends during the stay.

3. Liability of Food & More GmbH

Food & More GmbH shall be liable for the fulfillment of all obligations arising from the contract. Claims for damages shall be excluded.

The customer may not claim compensation except in the case of damages to life, limb or health where Food & More GmbH is responsible for a violation of duty as well as any other damage arising from a deliberate or grossly negligent violation of duty on the part of Food & More GmbH or damages caused by a deliberate or negligent violation of duties typical for this type of contract by Food & More GmbH. A breach of obligation on the part of Food & More GmbH is deemed to be equivalent to that of a statutory representative or vicarious agent.

4. Pets

We do not accept pets. However, as an exception and subject to prior notice, dogs are permitted in rooms 1, 4, 6 and 16 of the guest house.

5. Room allocation, check-in and check-out

Unless expressly agreed otherwise, the guest is not entitled to reserve a specific room. Rooms are available from 3 pm on the day of arrival and must be vacated by 11 am on the day of departure. Alternative times may be arranged on request.

6. Parking

Vehicles may be parked in the grounds of the guest house. Where a parking space is made available, this does not constitute a custody agreement. Food & More GmbH is not obliged to provide surveillance of the property. Food & More GmbH shall not be liable for the loss or damage of vehicles parked on its property, or their contents, except in the case of intentional or gross negligence. Section 3 (2-4) of these Terms and Conditions shall apply accordingly to claims for damages.

7. Prices and terms of payment

Please refer to the enclosed price list for the current rates. This does not include local levies that are charged in accordance with the respective municipal law, such as the visitor's tax. The costs for the entire stay are payable on departure.

8. Travel cancellation insurance

Travel cancellation insurance is not included in the room price. We recommend that you purchase appropriate insurance cover.

9. Cancellation or non-utilisation of the accommodation

Guests may only withdraw from the contract concluded with Food & More GmbH if the right of withdrawal has been specifically agreed to on a case-by-case basis, if a statutory right of withdrawal exists or if Food & More GmbH expressly consents thereto. The right of withdrawal and any consent to the cancellation of the contract must both be made in writing. Where a specific date has been agreed for exercising the right of free cancellation, the customer may cancel the contract until this date without incurring payment or damage compensation claims on the part of Food & More GmbH. The right of withdrawal is no longer valid if it is not exercised in the prescribed form in respect of Food & More GmbH prior to the agreed date. If the right of withdrawal has not been agreed or has already expired, no statutory right of withdrawal exists and Food & More GmbH does not consent to the cancellation of the contract, Food & More GmbH remains entitled to the agreed remuneration, the non-utilisation of the services notwithstanding. Nevertheless, Food & More GmbH shall offset any income arising from the letting of the rooms to other parties and any expenses saved. If the room(s) cannot be let to other parties, Food & More GmbH may demand the contractually agreed remuneration and make a flat-rate deduction for expenses saved. In this case, the guest shall be obliged to pay 90% of the contractually agreed rate for the accommodation, with or without breakfast. The guest is entitled to provide evidence that the aforementioned claim did not arise or that it did not arise to the extent claimed.

10. Breakfast

The guest house serves breakfast between the hours of 7.30 and 10.30 am.

11. Final provisions

Any amendments or supplements to this contract or these General Terms and Conditions shall require the written form. Unilateral amendments or supplements on the part of the guest shall be invalid. Should individual provisions of these General Terms and Conditions be held to be invalid or unenforceable, this shall not affect the remaining provisions. Furthermore, the statutory provisions shall apply. This contract shall be subject to German law. The United Nations Convention on Contracts for the International Sale of Goods and the conflict of laws regulations shall be excluded. To the extent permitted by law, it is agreed that the place of jurisdiction shall be Munich.

Section 34 BDSG (Federal Data Protection Act) provides for the right of access to personal data.
